



Edmonds Client Appreciation Giveaway

Official Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. Eligibility

Open only to the clients ("Client" is any account sending in a case) of Edmonds Dental Prosthetics, Inc. (Sponsor) based on the following criteria:

- a) Legal resident of the 50 United States and the District of Columbia
- b) Must be eighteen (18) years old or older at the time of entry
- c) Licensed dentist and staff member
- d) Must be current with his/her account balance (no invoices may be more than current month plus 60 days past due)

Subject to all applicable federal, state, and local laws and regulations. Void where prohibited.

2. Agreement to Official Rules
